I. Form of Contract

TIME-BASED

This CONTRACT (hereinafter called the “Contract”) is made on the ___ day of the month of _____, 2021, between, on the one hand, **Direkcija za puteve Kantona Sarajevo**, an institution incorporated under the laws of Bosnia and Herzegovina and having its principal place of business at Hamida Dizdara 1, 71000 Sarajevo, Bosnia and Herzegovina (hereinafter called the “Client”)

and,

on the other hand, **Joint Venture: IRD Engineering S.r.l. and PPG d.o.o.** consisting of the following entities, each member of which will be jointly and severally liable to the Client for all the Consultant’s obligations under this Contract, namely, **IRD Engineering S.r.l.** (lead member), a corporation incorporated under the laws of Italy and having its principal place of business at Lungotevere Delle Navi 30, 00196, Rome, Italy and **PPG d.o.o.** (member), a corporation incorporated under the laws of Bosnia and Herzegovina and having its principal place of business at Bulevar Meše Selimovića 81A, 71000 Sarajevo, Bosnia and Herzegovina (hereinafter called the “Consultant”).

WHEREAS

- (a) the Client has requested the Consultant to provide certain consulting services as defined in this Contract (hereinafter called the “Services”) in the amount of 1,263,600.00 Euro.

Total amount consists of:

- Total Costs of Financial Proposal1,080,000.00 Euro
- Value added Tax (17%)183,600.00 Euro

- (b) the Consultant, having represented to the Client that it has the required professional skills, expertise and technical resources, has agreed to provide the Services on the terms and conditions set forth in this Contract;
- (c) the Client has received a loan from the European Bank for Reconstruction and Development toward the cost of the Services and intends to apply a portion of the proceeds of this loan to eligible payments under this Contract, it being understood that (i) payments by the Bank will be made only at the request of the Client and upon approval by the Bank; (ii) such payments will be subject, in all respects, to the terms and conditions of the loan agreement, including prohibitions of withdrawal from the loan account for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of the Bank, is prohibited by the decision of the United Nations Security council taken under Chapter VII of the Charter of the United Nations; and (iii) no party other than the Client shall derive any rights from the loan agreement or have any claim to the loan proceeds;

NOW THEREFORE the parties hereto hereby agree as follows:
