Invitation for Tenders

Canton Sarajevo, Ministry of Traffic, street Reisa Džemaludina Čauševića 1, 71000 Sarajevo, Bosnia and Herzegovina (hereinafter referred to as “the Employer” or “the Client”), has received a loan from the European Investment Bank hereinafter referred to as “the Bank”, and intends using part of the proceeds towards the cost of **Sarajevo Urban Transport Project - Procurement of 10 (ten) new trolleybuses and related post-sales services, all in accordance with Purchaser's Supply Requirements**, hereinafter referred to as “the Project”.

Procurement will be carried out in accordance with the “Guide to Procurement for projects financed by the EIB” (edition July 2024), which is published on the Bank's website.

The Client now invites tenders for the following contract, hereinafter referred to as “the Contract”, to be funded from part of the above proceeds:

Tendering for contract to be financed with the above proceeds is open to candidates from all countries.

Pursuant to its Sanctions Policy, the Bank shall not provide or otherwise make funds available, directly or indirectly, to or for the benefit of an individual or entity that is subject to financial sanctions imposed by the EU, either autonomously or pursuant to the financial sanctions decided by the United Nations Security Council on the basis of article 41 of the UN Charter.



To be qualified for the award of a Contract, tenderers must satisfy the criteria stated in the Tender Document.
